APPOINTMENT ORDER UNDER SHAHEED QUOTA

On appointment, they will report to Sheet Branch Karachi Police office for further duty.

Their appointment is subject to the following terms and conditions:-

1. The appointment is purely on a temporary basis and shall be confirmed upon successful completion of a three-year probation period as per Police rule.
2. The appointment shall be governed by the Repeal of the Police Act, 1861 and the Revival of Police Order, 2002 (Amendment) Act, 2019, along with the prevailing laws, Police Rules, and all other applicable rules and regulations.
3. The appointee shall be liable for transfer and may be required to serve in any part of Sindh Province.
4. In case of resignation from the post/service without providing two months' prior notice, the appointee shall be required to deposit an amount equivalent to two months' salary into the Government Treasury.



5. The appointee must report to their place of posting and assume duties within **fifteen (15) days** from the date of issuance of this appointment order. Failure to report within the stipulated time will result in automatic cancellation of this order without any further notice.
6. No TA/DA (Travel Allowance/Daily Allowance) shall be admissible for the purpose of joining duty.
7. The appointment shall be liable to cancellation if any of the above terms and conditions are violated or in case any false information or forged documents are discovered at any stage. Such action may also attract criminal proceedings against the appointee.

The appointees are required to report to their place of posting to assume duty and complete all necessary formalities.
