APPOINTMENT ORDER UNDER SHAHEED QUOTA

On appointment, he will draw pay from his place of posting against the existing vacancy.

His appointment is subject to the following terms and conditions:-

1. The appointment is purely on a temporary basis and shall be confirmed upon successful completion of a three-year probation period as per Police rule.
2. The appointment shall be governed by the Repeal of the Police Act, 1861 and the Revival of Police Order, 2002 (Amendment) Act, 2019, along with the prevailing laws, Police Rules, and all other applicable rules and regulations.
3. The appointee shall undergo Basic Training Courses in accordance with Chapters 12 and 19 of the Police Rules, 1934, as well as any other specialized training programs prescribed by the Training Branch, Sindh, from time to time.
4. The appointee shall be liable for transfer and may be required to serve in any part of Sindh Province.
5. In case of resignation from the post/service without providing two months' prior notice, the appointee shall be required to deposit an amount equivalent to two months' salary into the Government Treasury.
6. The appointee must report to his place of posting and assume duty within fifteen (15) days from the date of issuance of this appointment order. Failure to report within the stipulated time will result in automatic cancellation of this order without any further notice.
7. No TA/DA (Travel Allowance/Daily Allowance) shall be admissible for the purpose of joining duty.



8. The appointment shall be liable to cancellation if any of the above terms and conditions is violated or in case any false information or forged documents are discovered at any stage. Such action may also attract criminal proceedings against the appointee.

The appointees are required to report to his place of posting to assume duty and complete all necessary formalities.
